

## **PRIVACY NOTICE**

### **Introduction**

This document refers to personal data, which is defined as information concerning any living person (a natural person who hereafter will be called the Data Subject) that is not already in the public domain.

The General Data Protection Regulation (GDPR) seeks to protect and enhance the rights of data subjects. These rights cover the safeguarding of personal data, protection against the unlawful processing of personal data and the unrestricted movement of personal data within the EU. It should be noted that GDPR does not apply to information already in the public domain.

### **Personal Data**

When working exclusively as a data processor, L Lynch Plant Hire & Haulage Ltd will be acting on the instruction of its client, and will work hard to ensure that the client is fully GDPR compliant.

Some personal data may be collected about you from the forms and surveys you complete, from records of our correspondence and phone calls and details of your visits to our website, including but not limited to personally identifying information like Internet Protocol (IP) addresses. ## Consent

## Disclosure

L Lynch Plant Hire & Haulage Ltd may on occasions pass your Personal Information to third parties exclusively to process work on its behalf. L Lynch Plant Hire & Haulage Ltd requires these parties to agree to process this information based on our instructions and requirements consistent with this Privacy Notice and GDPR.

L Lynch Plant Hire & Haulage Ltd do not broker or pass on information gained from your engagement with the agency without your consent. However, L Lynch Plant Hire & Haulage Ltd may disclose your Personal Information to meet legal obligations, regulations or valid governmental request.

## Retention Policy

L Lynch Plant Hire & Haulage Ltd will process personal data during the duration of any contract and will continue to store only the personal data needed for five years after the contract has expired to meet any legal obligations. After five years any personal data not needed will be deleted.

## Data storage

Data is held in England using multiple servers. L Lynch Plant Hire & Haulage Ltd does not store personal data outside the EEA.

## Your rights as a data subject

At any point whilst L Lynch Plant Hire & Haulage Ltd is in possession of or processing your personal data, all data subjects have the following rights:

- Right of access - you have the right to request a copy of the information that we hold about you.
- Right of rectification - you have a right to correct data that we hold about you that is inaccurate or incomplete.
- Right to be forgotten - in certain circumstances you can ask for the data we hold about you to be erased from our records.

- Right to restriction of processing – where certain conditions apply you have a right to restrict the processing.
- Right of portability – you have the right to have the data we hold about you transferred to another organisation.
- Right to object – you have the right to object to certain types of processing such as direct marketing.
- Right to object to automated processing, including profiling – you also have the right not to be subject to the legal effects of automated processing or profiling

In the event that L Lynch Plant Hire & Haulage Ltd refuses your request under rights of access, we will provide you with a reason as to why, which you have the right to legally challenge.

### **You can request the following information:**

- Identity and the contact details of the person or organisation L Lynch Plant Hire & Haulage Ltd that has determined how and why to process your data.
- Contact details of the data protection officer, where applicable.
- The purpose of the processing as well as the legal basis for processing.
- If the processing is based on the legitimate interests of L Lynch Plant Hire & Haulage Ltd or a third party such as one of its clients, information about those interests.
- The categories of personal data collected, stored and processed.
- Recipient(s) or categories of recipients that the data is/will be disclosed to.
- How long the data will be stored.
- Details of your rights to correct, erase, restrict or object to such processing.
- Information about your right to withdraw consent at any time.
- How to lodge a complaint with the supervisory authority (Data Protection Regulator).
- Whether the provision of personal data is a statutory or contractual requirement, or a requirement necessary to enter into a contract, as well as whether you are obliged to provide the personal data and the possible consequences of failing to provide such data.
- The source of personal data if it wasn't collected directly from you.
- Any details and information of automated decision making, such as profiling, and any meaningful information about the logic involved, as well as the significance and expected consequences of such processing.

### **To access what personal data is held, identification will be required**

L Lynch Plant Hire & Haulage Ltd will accept the following forms of ID when information on your personal data is requested: a copy of your driving license, passport, birth certificate and a utility bill not older than three months or a national ID card. A minimum of one piece of photographic ID listed above and a supporting document is required. If L Lynch Plant Hire & Haulage Ltd is dissatisfied with the quality, further information may be sought before personal data can be released.
